Customs Broking Experience Assessment

The Concept

The Customs Broking Experience Assessment concept is designed to test the “customs broking experience” of a candidate.

Each assessment seeks to test the candidate’s ability to provide advice and respond to real life situations that are encountered by Customs Brokers in the normal course of the business of international trade, rather than being a more intensive test of the knowledge gained during completion of the “approved course of study”.

The situations presented in the assessments are drawn from actual business events and the responses should provide appropriate advice and take the action expected of a professional business adviser, i.e. a Customs Broker.

The candidate’s response should reflect a structured approach that demonstrates consideration of the actions, responsibilities and rights of all parties involved in and affected by the particular circumstances.

A conscious decision has been made not present a subset of questions that may suggest the course of action to take.

The Assessment will consist of 2 papers each of 2 hour duration, with a 30 minute break after the first paper. Candidates must achieve a combined mark of 70% to be successful.



Assessment Outline

Date

Saturday 15 November 2014.

Availability

To be held simultaneously around Australia in each capital city.

Venues

myfreightcareer has access to multiple venues in each capital city and we will select the venue most suitable to the number of persons attempting the assessment.

Timing

The Assessment will consist of 2 papers each of 2 hours duration with a 30 minute break after the first paper. Candidates must achieve a combined minimum mark of 70% to be successful.

Pre-National Experience Assessment Study Groups

Persons interested in becoming accredited under the NCCC Scheme must successfully complete the "TLIX5054A- Comply with Biosecurity Border Clearance" Unit of Competency, which is currently delivered by **myfreightcareer** as part of our nationally recognised Diploma of Customs Broking.
